

2023 Girl Scout Cookie Program Caregiver Permission & Responsibility Agreement

Prior to receiving Girl Scout Cookie Program materials, please complete this form and return it to your Troop Cookie Manager.

My Girl Scout, _____, in troop _____ has my permission to participate in the 2023 Girl Scouts of the Northwestern Great Lakes, Inc. Cookie Program.

In so doing, I agree to the following:

- ✓ I verify that she is registered member of Girl Scouts of the USA for the 2022–2023 membership year.
- ✓ I will provide adult supervision and guidance at all times.
- ✓ I will not collect cookie money from customers until product is delivered (can collect money from customers donating cookies and from Smart Cookies Girl Delivery).
- ✓ I will give collected cookie money to the troop cookie manager promptly and frequently.
- ✓ I accept responsibility for products received and money owed, and I understand that products cannot be returned.
- ✓ I understand that failure to turn in all monies owed for products will result in collection/legal action.
- ✓ I understand that my daughter, friends, and family are not to distribute order cards or take any orders prior to the official start date of the Cookie Program, January 18, 2023, abiding by the Girl Scout Promise and Law.

Internet Safety

- ✓ I will not give out information such as my address, telephone number(s), caregiver’s work address/telephone number(s), and the name/location of my school without the permission of my parent or guardian.
- ✓ I will tell an adult right away if I come across or receive any information that makes me feel uncomfortable.
- ✓ I will always follow the rules of Internet sites, including those rules that are based on age of use, caregiver approval and knowledge, and public laws.
- ✓ I will never agree to get together with someone I "meet" online without first checking with my caregiver. If my caregiver agrees to a meeting, I will arrange it in a public place and bring a caregiver along.
- ✓ I will never send a person my picture or anything else without first checking with my caregiver.
- ✓ I will talk with my caregiver so that we can set up rules for going online. We will decide on the time of day that I can be online, the length of time that I can be online, and the appropriate areas for me to visit. I will not access other areas or break these rules without permission.
- ✓ I will follow all of the Girl Scout Terms and Conditions related to Digital Cookie.
- ✓ I will practice online etiquette at all times when online by not spamming others, not bullying, not using bad language.
- ✓ I will be guided by the Girl Scout Promise and Law in all that I do online.

Girls are only to use the Internet to market the Girl Scout Cookie Program to friends and family (for clarity, “friends and family” are people whom the girl or her family personally know). Advertising the Cookie Program via online auction or sales websites such as Craigslist, Facebook sales pages, or eBay is strictly prohibited. **The only permissible online ordering method is via Digital Cookie through Smart Cookies.**

- ✓ Any recognition or Cookie Dough discrepancies must be reported no later than June 30, 2023.
- ✓ Cookie Dough earned during the 2022 Cookie Program expires on December 15, 2023.
